DEADLINES

This Notice of Appeal form for a General or Complex Appeal must be received by the Appeals Coordinator by the earliest of the following:

- 20 days after the appellant received the decision which is objected to.
- 20 days after the appellant became aware of this decision or should have become aware of this decision, or
- 45 days after this decision was made.

The Appeals Coordinator **must reject any late or incomplete Notices of Appeals** unless the Coordinator is satisfied that rejecting the appeal would be against the public interest.

VALID GROUNDS

You can only use this form to appeal the decision of a Director or an Officer under the *Public Lands Act* or the *Public Lands Administration Regulation* on any, or all, of the following grounds:

- 1) The Director or Officer who made the decision:
- erred in the determination of a material fact on the face of the record,
- erred in law,
- exceeded the Director's or Officer's jurisdiction or authority, or
- did not comply with a regional plan approved under the authority of the Alberta Land Stewardship Act.
- 2) The decision is expressly subject to appeal under Section 15(4) of the *Public Lands Administration Regulation* or Section 59.2(3) of the *Public Lands Act* (this means a deemed rejection because of the failure of a Director or Officer to approve or reject an application for a disposition, authorization, or approval within a 30 day time limit unless a time extension was approved).
